### HSR-sponsored Special Supplement on VA Virtual Care in JGIM is Live!

The supplement, titled “[Virtual Care in the Veterans Health Administration: Evidence to Advance Access, Engagement, and Outcomes](#)” is a major milestone in a three-year collaboration between the Virtual Care CORE and VA’s Office of Connected Care (OCC). The articles highlight findings from a VA [State of the Art \(SOTA\) Conference on Virtual Care](#), convened in 2022, during which three workgroups discussed opportunities to: 1) address VA virtual care access disparities, 2) enhance Veteran engagement with virtual care, and 3) define and improve outcomes influenced by virtual care.

## Final Reminder: FY25 THRIVE Scholar RFA

On behalf of the Telehealth Research and Innovation for Veterans with Cancer (THRIVE) Center, please see their FY25 Health Equity Scholars (previously *Associate Investigator*) Program RFA. This training program includes ~\$25k in FY25 funding for early career investigators (pre-major award such as CDA, R01, K) and an extensive mentorship and foundational curriculum in areas of teleoncology and health equity research. Applications consist of a cover letter (½ page max), personal statement (700-word max), [NIH Biosketch](#) (see example in link), and Letter of Support from one mentor or supervisor.
