# OCC FY24 Rapid QI/Evaluation Project and ATLAS RFAs

The Office of Connected Care has two funding opportunities (so far) for FY24. The first is their annual request for proposals addressing OCC's rapid QI and evaluation priorities. Proposals may request up to \$250k over two years, with a maximum of \$150k in either year. Priorities and

## Study: Assessing Collaborative Research Networks to Enhance Research Value

To better understand what individual and environmental factors contribute to successful collaborative research, Dr. Elizabeth Stevens at NYU Langone Health is conducting a research study that will collect information about our consortium's members and their collaboration networks.

Please check your VA spam filters! So far, two emails have been sent with the subject "Invitation to take part in a survey about research collaboration" on June 6 and June 20 from <a href="noreply@nyulangone.org">noreply@nyulangone.org</a>. The study will last approximately 5 years and involve several parts including a baseline survey, the possibility of a one-time 60-minute interview, and four follow-up surveys. The surveys ask about your background, personality, perceptions of collaborative research, research productivity, and collaboration networks. All study activities are 100% optional. The second OCC funding opportunity for FY24 specifically solicits proposals for a rigorous evaluation and implementation project on the ATLAS (Accessing Telehealth through Local Area Stations) program. This funding opportunity has a maximum budget of \$500k in year one, with the potential for renewal in year two. Full details are attached in the ATLAS RFA with this newsletter.

#### **THRIVE FY24 Pilot Project RFAs**

The TeleHealth Research and Innovation for Veterans with Cancer (THRIVE) team are requesting proposals for pilot studies that are focused on virtual care modalities for Veterans with cancer, with specific interests in social determinants of telehealth and health equity. Pilot studies can be at the facility, VISN or national level. In this application cycle, three pilots will be funded, all of which must integrate of social determinants for telehealth and/or health equity; of these three pilots:

- Two will be funded by the Office of Rural Health these must study applications of telehealth in rural
  populations (at least 50% of study participants or population designated as rural by Rural-Urban Commuting
  Area (RUCA) codes; they may be research or QI/evaluation projects
- One will be funded by HSR&D and *must* be an IRB approved or exempt research project
