**Final Reminder: Office of Connected Care Funding Opportunities**

There is still time to submit proposals for the Office of Connected Care’s two separate RFAs, described below. The RFAs and compiled Q&A for the General RFA can be found in the email containing this newsletter as well as on the VC CORE [SharePoint](#).

- **The (General) OCC FY25 RFA** solicits rapid QI, evaluation, and partnership development projects that address one of five specific priority project areas, each with a set of guiding questions and/or design recommendations.
  - **Priority project areas:**
    1. Pilot Evaluation of VA Provider Connect (PrC)
    2. Pilot Evaluation of VA Health Chat (HC)
    3. Evaluation of impacts of Remote Patient Monitoring-Home Telehealth on healthcare utilization/outcomes
    4. Asynchronous Clinical Reminders (ACRs) to complete screening questionnaires in advance of appointments
    5. Projects that evaluate use cases of Patient Generated Health Data (PGHD)
  - **Budget:** Projects may be 1-2 years, with maximum budgets of \$150k per year and \$250k overall
  - **Deadline:** 11:59 PM EST on Monday, September 9

- **The TECC Funding RFA** solicits proposals for effectiveness evaluations that address specific requirements of the Cleland Dole Act. which mandates an evaluation of the effectiveness of VA telehealth across contexts of care in which it is delivered.
  - **Priority project areas:** For FY25, TECC is only soliciting proposals for effectiveness evaluations that focus on *specialty care (especially cardiology, gastroenterology (GI), and emergency/urgent care)*.
  - **Budget:** Projects may be 1-2 years, with maximum budgets of \$150k per year
  - **Deadline:** 11:59 PM EST on Friday, September 13
