Guidance Documents – Under Services

- Each service published their own RFAs
- Services differed in their pre-authorization requirements:
 - HSRD required Intent to Submit (ITS) through ART for all RFAs
 - RRD required pre-applications for all RFAs
 - BLRD and CSRD required LOIs for some RFAs but not others
- RFAs defined both the research topics the service was interested in supporting as well as the details of the award (budget, duration, review criteria, application requirements).



Guidance Documents – Under Portfolios

- All RFAs are cross-portfolio. The RFAs define the Award Type, Budget, Duration, Review Criteria, and application requirements but do not define specific research topics.
- All Broad Portfolios (BPs), Actively Managed Portfolios (AMPS), and Programs publish their own Notices of Special Interest (NOSIs).
 - NOSIs define the research topics the BP, AMP, or Program is soliciting
 - Each NOSI lists the cross-portfolio RFAs that can be applied to through that NOSI.
- The Scientific Review Groups (SRGs) have not changed. They convene on the same schedule. Purview statements have been combined into a single document with minor tweaks.





Decisions needed when submitting an ISRM application

- Which NOSI should you apply through? (Identify research topic)
 - Which portfolio are you applying to? (Some NOSIs are cross-portfolio, for example Women's Health)
- Which RFA/award type is appropriate for your project? (Mentored, independent, clinical trial, etc.)
- Which SRG do I want my application review on? (Check SRG purviews)
 - Perhaps the most important decision
 - Defines what cycles you can apply. (Some SRGs convene Winter/Summer others convene Spring/Fall)
- ORD makes final decisions on purviews feedback will be given in pre-app approval notification.

Submit a Pre-Application Submit a Full Research Application

- Align your
 research idea with
 one of the VA ORD's Broad
 Portfolios (BPs),
 Actively Managed
 Portfolios (AMPs),
 or Programs.
- NOSIs describe research topics of interest.
- Choose a NOSI that aligns with your research topic.
- Each NOSI lists the RFAs that can be applied to.
- Choose an RFA that fits your research mechanism (e.g., 101, 121).
- Determine the appropriate SRG based on your research topic and the RFA's guidelines.
- Consider the SRG's review cycles when planning your submission.

- Submit a preapplication to get initial feedback on your research idea.
- Include any necessary waiver requests.
- If your preapplication is approved, submit a full research application following the guidelines outlined in the RFA



Reminders & Updates

- Revised NOSIs and RFAs will be published in early January. Use these revisions for February 1 pre-application submissions.
- Starting in the Winter 2025 round, grant numbers for resubmissions and renewals will be updated to the "RD" IC code (from BX/CX/HX/RX). Do not be alarmed when you see grant numbes changing.
- Remember different RFAs have different pre-application deadlines (CTs, CDA, RCS, and Translational studies are 3 months earlier)
- ALL applications, including resubmissions, require a pre-application.
